## Payment Facility through Childcare Voucher Scheme

**The scheme outlined below closed to new applicants in October 2018.**

**However, parents already purchasing these vouchers through their employer can continue to do so, and use them at the Oratory Prep School.**

Payment may be made through the Childcare Voucher Scheme with the following guidelines:

1. Fee Payment may be made through a Childcare voucher Scheme up to and including the term that your child turns five.
2. Please request one payment per term from your Childcare voucher provider and this to be paid on or before the first day of term when Fee payment is due.
3. Following your child's fifth birthday The Oratory Preparatory School will receive Childcare voucher payment for the After School Club only. On receipt of your Fee invoice please transfer from your Childcare voucher provider, the amount charged for After School Club using this as reference.
4. Payment is not accepted for After School Activities or any other charges through the Childcare Voucher Scheme.

## **Government Tax-Free Childcare**

Parents can get up to £500 every 3 months (£2,000 a year) for each of their children to help with the costs of childcare.

For families who receive Tax-Free Childcare, the government will pay £2 for every £8 you pay your childcare provider. This is paid via an online childcare account that parents set up for their child.

The Oratory Prep School has registered with the Government's Tax Free Childcare Scheme and has a childcare provider account.
